INSTRUCTIONS TO APPLICANTS

1. Read the requirements for a licence carefully.
2. If you can meet all of the requirements, complete the application form in full.
3. An authorized representative of the company you want to work for must complete the "Certificate of Intent".
4. Bring the completed application form to the Sault Ste. Marie Police Service, 580 Second Line East. An appointment will be made for you to complete the written test. You will be required to pay a **non-refundable administration fee of \$15.00** at the time you make your appointment.
5. If you are granted a licence, you will need to provide two (2) passport size (1 1/2" x 1 1/2") photographs.

REQUIREMENTS FOR LICENCE

1. Be at least 18 years of age.
2. Have a valid unrestricted class "G" driver's licence with no more than 9 demerit points issued under the authority of the *Highway Traffic Act of Ontario*.
3. Not have a criminal record for which a pardon has not been granted.
4. Not have been found guilty of an offence under the *Liquor Licence Act of Ontario* pertaining to the illegal sale or purchase of liquor within the preceding three years.
5. Not be suffering from any condition that might render you unfit to drive.
6. Provide "Certificate of Intent" from your employer.
